### HOW DO I SIGN UP?

- Memberships are available from the Distribution Centers. To locate a DC, please email [csPhilippines@FreeLife.com](mailto:csPhilippines@FreeLife.com) and provide your address and contact details.
- There is a P1250 membership fee (VAT inclusive) that includes:
  - Personalized website with online business tools.
  - Gift of a Marketing Executive Business Kit that includes promotional materials and information to introduce you to FreeLife.

### WHAT ARE THE REQUIREMENTS?

- Some forms are required to do business as a Marketing Executive in the Philippines
  1. Marketing Executive Application and Agreement or agree to the Policies and Procedures online through your “My FreeLife Office” area on [FreeLife.com](http://FreeLife.com)
  2. U.S. IRS W-8BEN Form
  3. TIN Declaration
  4. Proof of the TIN card with photo; or, TIN card without photo, plus one other government-issued photo ID card; or, TIN certification or application (BIR Form # 1902 or 1905), plus one other government-issued photo ID card.
  5. Enroll on Direct Deposit
- To start doing business as a Marketing Executive, FreeLife only needs to receive the Application and Agreement. However, all of the documents listed above must be received by FreeLife before any commissions are paid. Documents can be faxed to: 632-910-7028, or given to your DC to give to the FreeLife office.

### HOW TO PURCHASE PRODUCTS?

- Purchases of *TAIslim*®, *GoChi*®, and *Himalayan Goji Juice*® are made in case allotments (4-bottles) from the Distribution Center.
- Payments are made using cash or credit card and will depend on the DC. Please ask your DC what forms of payment is accepted.

### PRODUCT PRICING

- One case of *TAIslim* (4 1-liter bottles): P8,848 (includes VAT)
- One case of *GoChi* (4 1-liter bottles): P8,815 (includes VAT)
- *GoChi* Value Pack (6 cases): P44,075 (includes VAT)
- One case of *Himalayan Goji Juice* (4 1-liter bottles): P8,520 (includes VAT)
- *Himalayan Goji Juice* Value Pack (6 cases): P42,600 (includes VAT)
- All orders may be picked up at the DC. Please contact FreeLife if you wish to be connected with a DC.

### HOW DO I GET PAID?

- Direct Deposit is a quick, convenient, and secure way to receive your commissions. There are three ways to enroll:
  1. Login to your website, go to the “My FreeLife Office” area, and click on “Direct Deposit” in the left hand navigation.
  2. Complete the Direct Deposit enrollment form with all required information and submit it to the Philippines Service Center, details below.
  3. Visit your local DC and complete your enrollment form there.

- Note that you will not be able to receive commissions until FreeLife receives your Direct Deposit information.

- All Marketing Executives can enroll Marketing Executives and Customers in other countries where FreeLife is currently doing business.
